

Terms and Conditions for the Stainless Steel Egyptian God Cards

1. Introduction

1.1. This contest is organised by Games Center (tournamentcenter), referred to as "Organizer". The contest allows customers to participate in the contest to win one (1) Ultra Rare Normal Monster version of Black Luster Soldier by purchasing at least one of up to 8000 units of the limited edition collectible Stainless Steel Egyptian God Cards

2. Eligibility

2.1. The contest is open to customers who purchase at least one of up to 8000 units of the limited edition collectible Stainless Steel Egyptian God cards.

3. Contest Period

3.1 The contest will run from Friday December 15, 2023 until January 9, 2024 at midnight CET. Purchases made during this period are eligible for participation.

4. Participation

- 4.1. Participants must purchase one or more units of the limited edition collectible to be eligible for the contest. One (1) unit purchased gives the participant one (1) chance of winning one (1) Ultra Rare Normal Monster version of Black Luster Soldier.

- 8.3 The winner will be announced in Q1 2024 once the products are ready to be shipped. They will be informed via email.
